### GUIDANCE NOTES, SUBMISSION INSTRUCTIONS

#### Section 1. PERSONAL DETAILS OF LICENCE HOLDER

Please ensure that your Surname and First Name(s) are entered exactly as per your Passport document and pilot licence.

#### Section 2. DETAILS OF APPROVED TRAINING ORGANISATION WHICH PROVIDED PBN TRAINING

The ATO or AOC holding enterprise entered must hold Approval or recognition from the appropriate Competent Authority (Civil Aviation Authority where the enterprise has its principal place of business) that the PBN training and testing provided by that enterprise meets the requirements of EU Regulation 2016/539. This must be appropriately documented by a letter or Certificate provided by that Competent Authority and attached to this application form.

#### Section 3. DECLARATION BY LICENCE HOLDER

The Declarations made at 3.1. and 3.2. and attached Proficiency Check/Skill Test mean that the pilot certifies that:-

(a) the pilot has successfully completed a course of theoretical knowledge including PBN, in accordance with FCL.615 of Annex I (Part-FCL);

(b) the pilot has successfully completed flying training including PBN, in accordance with FCL.615 of Annex I (Part-FCL);

(c) the pilot has successfully completed either a skill test in accordance with Appendix 7 to Annex I (Part-FCL) or a skill test or a proficiency check in accordance with Appendix 9 of Annex I (Part-FCL).

#### Section 4. PERSONAL DETAILS OF THE CERTIFIED PBN EXAMINER

The Examiner's EU Part-FCL Licence must clearly show that they hold a PBN endorsement from their Competent Authority (endorsed either on the Licence or their Examiner Certificate or an equivalent document). A copy of the Licence/Certificate/document must be attached to this application.

#### Section 5. DECLARATION BY THE CERTIFIED PBN EXAMINER

5.1. The Examiner certifies that the PBN theoretical knowledge, flight training and Proficiency Check/Skill Test were satisfactorily completed by the applicant pilot in accordance with the PBN requirements of EU Regulation 2016/539.

5.2. The Examiner is responsible for the attachment of the documentary evidence for the ATO/AOC (see note for Section 2 above) and for their own Examiner documents (see note for Section 4 above). Failure to submit the required documentary evidence will result in delay or possible refusal of the application.

The data recorded in this form shall be used for the purpose of processing and maintaining the Flight Crew Licence for which the endorsement applies.
