i think its great that it is being reviewed however i dont think there is much wrong with it from an entry or on going basis. Just a couple of points.

- 1. Definately the licence should be reviewed every year as in the current climate and in the future retail agents will be closing down as more and more people book online, internet penetration is only about 22% of the population, once, if ever it gets more accessable in rural areas more and more people will book online so i can see retail agencies sales dropping from year to year.
- 2. As 99% of our turnover is by online or telesale credit card, we are paying the credit card companies 1.5% due to their risk of client cancelling payment if we did go bust. So in effect our clients are covered twice. Our cost in that is about 70,000 euro per year. I think that is definately an area as it says on the report that should be looked at.
- 3. Escrow accounts would be way to complicated.
