CORK AIRPORT (EICK)

Runway 16/34 Reconstruction and Airfield Ground Lighting (AGL) Renewal - Phase 2

For a period of 10 weeks commending on 13th of September 2021 (0200hr UTC), extensive runway pavement and associated civil and electrical refurbishment works will be undertaken to Runway 16/34 at Cork Airport.

The following restrictions will be in place for the full duration of the works: All information will be promulgated by NOTAM.

- Full closure of Runway 16/34 (lighting aids withdrawn from service)
- Reduced distances for Runway 07/25, with a temporary displaced Threshold Runway 07
- Full closure of Taxiways A,C and F (lighting aids on these taxiways withdrawn from service)
- Apron taxiway edge lighting, stop bars and Runway guard lights withdrawn from service.
- · All navigational aids withdrawn, with the exception of the CRK DVOR/DME
- Information on Instrument Flight Procedures withdrawn from service will be promulgated by NOTAM
- Low visibility procedures not available
- Fuelling facilities as per published hours of Operation
- Rescue and firefighting response reduced to Aerodrome Category 4
- Closed Runway and taxiways will be marked and lighted to indicate unavailability for use
- Closed portion of Runway 07/25 will be marked and lighted to indicate unavailability for use.

Remaining portion of Runway 07/25 will be available for existing general aviation operators based at Cork Airport (AFTA, Babcock, NHV)



- 1) Runway 07/25 will be operating with reduced distances originating from the current Runway 07/25 Threshold. A temporary relocated Runway 07 Threshold will be in place for the duration of the works
- 2) Distances above are subject to validation. Exact distances will be promulgated by NOTAM in due course.
- 3) All use of Runway 07/25 is strictly limited to Daytime VFR only.
- 4) Aircraft operations below 1500m Met visibility and/or VFR operations at night are strictly limited to Operators who operate under State exemptions.
- 5) Information on the operation and availability of the reduced declared distances and operating hours will be promulgated by NOTAM
- 6) Runway 25 available for take off and landings.
- 7) Runway 07 available for take off only (Landings on Runway 07 will be made available in the event of an emergency, subject to approval of Cork ATC)
