Temporary Restricted Area (TRA) in the vicinity of Cleggan & Inishbofin Co. Galway plus Inishturk & Clare Island Co. Mayo

Thursday 03rd to Sunday 06th September 2020

The Irish Aviation Authority in pursuance of Articles 7 and 10 of the Irish Aviation Authority (Standardised Rules of the Air) Order, 2019 (S.I. No. 266 of 2019), and in accordance with Commission Implementing Regulation (EU) No. 923/2012, SERA.3145 (Prohibited Areas and Restricted Areas), hereby directs as follows: -

A restriction (Temporary Restricted Area) on the flying of aircraft, including Small Unmanned Aircraft as defined in S.I. 563/2015, shall apply in the vicinity of **Cleggan & Inishbofin Co. Galway plus Inishturk & Clare Island Co. Mayo** in the Airspace contained within the under mentioned:

Lateral limits:

1. 53° 47' 41.82" N 009° 58' 26.54" W
2. 53° 32' 43.20" N 010° 02' 23.57" W
3. 53° 31' 16.48" N 010° 04' 44.48" W
4. 53° 32' 24.47" N 010° 06' 46.99" W
5. 53° 37' 03.19" N 010° 11' 36.62" W
6. 53° 42' 12.10" N 010° 07' 15.68" W
7. 53° 41' 28.34" N 010° 03' 51.84" W
8. 53° 47' 58.40" N 009° 59' 55.57" W

Vertical limits: SFC to 500 feet AMSL

Duration: The period of the restriction shall be from 0800hrs to 1800hrs UTC daily from 03rd to 06th September 2020

The Purpose of the TRA:

The purpose of the TRA is to ensure the safety of aircraft by separating BVLOS RPAS operations from other air traffic operating in the vicinity of **Cleggan & Inishbofin Co. Galway plus Inishturk & Clare Island Co. Mayo** in the periods cited.

Flight Restrictions & Exemptions:

The Airspace contained within the TRA is Class G.

Subject to any decision of the Flight Operations Department (FOD) of the Irish Aviation Authority to the contrary, the Airspace within the TRA is restricted to use by aircraft authorised by and in accordance with instructions and conditions established by FOD.

Small Unmanned Aircraft (SUA) including drones and rockets, operating privately or under Specific Operating Permission may not operate within the TRA without written Permission from the Flight Operations Authority and Event Organisers. SUAs may be subject to seizure by An Garda Síochána as evidence for potential prosecution and in the interest of Aviation Safety.

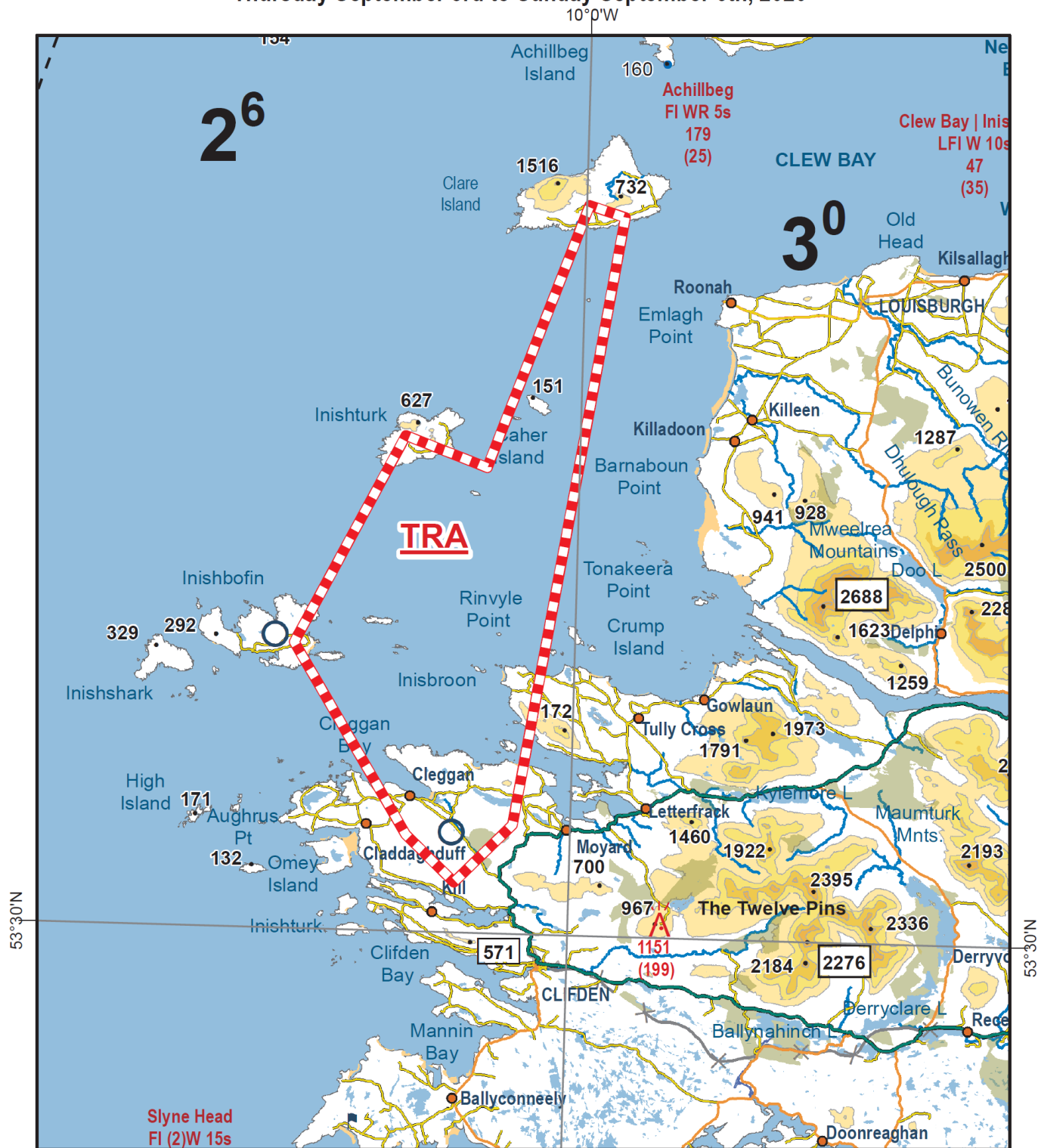
State aircraft, aircraft of the Irish Coastguard Service and the National Ambulance Service/ICRR (aircraft callsign Helimed 92) employed on an operational mission shall be exempt from the restriction.

Any exemptions, alleviations or permissions, granted to civil general air traffic by the Authority, are not valid within this Temporary Restricted Area during the period cited.

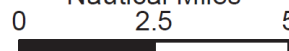
