Purpose of This Personnel Licensing Advisory Memoranda (PLAM).

This PLAM provides guidance for pilots, flight instructors and examiners on requirements for endorsements to be maintained in logbooks in accordance with Annex III PART-BFCL to Regulation (EU) 2020/357.

Applicability

The following endorsements are for use by instructors and/or examiners for endorsing logbooks when certifying accomplishment of requirements for pilot operating privileges. Each endorsement must be legible and include the instructor's/examiner's signature, Instructor's/examiner's name, date of signature, and Licence number. Any element included in an endorsement that does not form part of the certified training shall be struck out by ruling a line through that item.

Use of the Endorsement

The endorsements shall be entered the pilot's log book upon completion and satisfactory demonstration of proficiency in the applicable privilege. The endorsement shall be entered in the logbook of the pilot and signed by the head of training of the ATO or the DTO or the instructor that is responsible for the training, as applicable.

The endorsement may be entered onto the page where the training is recorded or may be placed on pages located at the front or rear of the logbook, or on pages assigned for such a purpose.

Each endorsement may be hand written in the logbook or copied and printed onto labels for easier use.

Each endorsement shall carry a wet signature regardless of method used for entry into a logbook.
