TEMPORARY FLIGHT RESTRICTION – In the vicinity of Ballydusker, Wexford on Thursday July 31st, 2025

The Minister of Transport acceding to a request from The Department of Justice for reasons related to security, has directed the Irish Aviation Authority to establish a temporary restricted airspace in the vicinity of Ballydusker, Wexford within which flight restrictions shall apply as detailed hereafter.

The Irish Aviation Authority in pursuance of Articles 7 & 10 of the Irish Aviation Authority (Rules of the Air) Order, 2019 (S.I. No. 266 of 2019) and in accordance with Commission Implementing Regulation (EU) No. 923/2012, SERA.3145 (Prohibited Areas and Restricted Areas), hereby directs as follows:-

A temporary restriction (Temporary Restricted Area) on the flying of aircraft, rockets as defined in S.I. No. 25 of 2023, including Unmanned Aircraft Systems (UAS) as defined in S.I. No. 24 of 2023 and Commission Implementing Regulation (EU) 2019/947, shall apply in the temporary restricted area (TRA) of airspace contained within the under mentioned:

Lateral limits:	A circle radius of 1.1NM centred on: 52° 15' 29.53"N, 006° 27' 23.82"W
Vertical limits:	SFC to 2000FT AMSL
Duration:	From 0800hrs UTC to 2200hrs UTC on Thursday July 31 st , 2025.

The airspace contained within the TRA is ICAO Class G.

Subject to any decision by the Irish Aviation Authority to the contrary, the airspace within the TRA is restricted to use by aircraft authorised by the Controlling Authority, An Garda Síochána.

Any exemptions, alleviations, or permissions granted to Civil General Air Traffic or Unmanned Aircraft Systems (UAS) operators by the Authority, are not valid within this TRA during the period cited.

Pursuant to Article 13 of S.I. 24 of 2023, where there is a suspected breach of the EASA Regulations, or the Order (S.I. 24 of 2023), a member of An Garda Síochána may, in accordance with Section 7 of the Criminal Justice Act 2006, detain a UAS.

A NOTAM will be issued in due course to notify of the TRA activation.
