FLIGHT RESTRICTION **NOTICE**

11-12 D'OLIER STREET DUBLIN 2

Temporary Flight Restriction in the vicinity of Rush, County Dublin

Sunday 03rd August 2025

The Irish Aviation Authority in pursuance of Article 7 paragraphs 3 and 7, and Article 10 of the Irish Aviation Authority (Standardised Rules of the Air) Order, 2019 (S.I. No. 266 of 2019), and in accordance with Commission Implementing Regulation (EU) No. 923/2012, SERA.3145 (Prohibited areas and Restricted areas), hereby directs as follows:-

A temporary restriction on the flying of aircraft, rockets as defined in S.I. No. 25 of 2023, including Unmanned Aircraft Systems (UAS) as defined in S.I. No. 24 of 2023 and Commission Implementing Regulation (EU) 2019/947, shall apply in the temporary restricted area (TRA) of airspace contained within the following volume of airspace:

Point 53°34'00.00" N, 006°05'20.00" W to Arc of 2.08 NM radius centred on **Lateral limits:**

> 53°31'57.33" N, 006°04'48.67" W to Point 53°29'53.82" N, 006°04'26.13" W to Point 53°29'49.86" N, 006°14'10.37" W to Arc of 0.5 NM radius centred on 53°30'20.00" N, 006°14'16.00" W to Point 53°30'52.34" N, 006°14'15.48" W to

Point 53°34'00.00" N, 006°05'20.00" W

Vertical limits: SFC to 2000FT AMSL

The period of the restriction shall be from 1345 UTC to 1645 UTC **Duration:**

on Sunday 03rd August 2025.

The Purpose of the TRA:

The purpose of the TRA is to ensure the safety of aircraft operating at the Rush Air Display, and of other aircraft operating in the vicinity of Rush in the periods cited.

Airspace Classification & Communication Service:

The airspace contained within the TRA shall be classified as ICAO Class G.

Unless otherwise advised by the Flying Display Director, aircraft operating at the air display shall use-Air/Ground Frequency 119.600MHz, and act in accordance with information provided by the Flying Display Director.

Flight Restrictions & Exemptions:

Flights Permitted in the TRA.

- State aircraft (including State Unmanned Aircraft Systems), aircraft of the Irish Coastguard Service, Aircraft Operators employed on an operational HEMS mission, shall be exempt from the restriction.
- ii. Flights by aircraft, including Unmanned Aircraft Systems, authorised by the Flying Display Director.
- iii. Rockets, with specific written permission from the Authority and the Flying Display Director.

b. Flights not permitted.

- i. Flights by all other aircraft, including Unmanned Aircraft Systems, and rockets, are not permitted.
- ii. Any exemptions, alleviations or permissions, other than those listed at 'a. Flights Permitted in the TRA' granted to aircraft, including Unmanned Aircraft Systems, and rockets, by the Authority, are not valid within the TRA during the periods cited.
- iii. Any aircraft, including Unmanned Aircraft Systems, directed by the Authority not to enter the TRA, including aircraft already authorised as a permitted flight by the Flying Display Director as per a.ii.

Pursuant to Article 13 of S.I. No. 24 of 2023, where there is a suspected breach of the EASA Regulations, or the Order (S.I. No. 24 of 2023), a member of An Garda Síochána may, in accordance with Section 7 of the Criminal Justice Act 2006, detain the Unmanned Aircraft Systems.

Pursuant to Article 22 of S.I. No. 24 of 2023, if it appears to a member of An Garda Siochana, that a Unmanned Aircraft Systems is likely to be operated in contravention of the EASA Regulation, the IAA Act 1993, the Order (S.I. No. 24 of 2023), or any Directions thereunder, or if a member of An Garda Siochána reasonably suspects the Unmanned Aircraft Systems is being, or is intended to be operated in the commission of any offence, they may direct the operator or remote pilot, not to operate the Unmanned Aircraft Systems.

A NOTAM will be issued in due course by the AIS office to notify of the TRA activation.
