





# **SECTION 9**

# **DECLARATION ADMINSTRATIVE NOTES**

- 1) MSN means Manufacturer Serial Number.
- 2) The 'Type(s) of operation' refers to the type of operations conducted, for example, non-commercial operations in a complex motor-powered aircraft (PART-NCC) or commercial specialised operations (PART-SPO), e.g. aerial photography flights, survey flights, aerial advertising flights, parachute operations, maintenance check flights (MCF), etc.
- 3) The Information required for an organisation responsible for the continuing airworthiness management shall include the name of the organisation, its address, and the approval reference.
- 4) The operator shall obtain a prior approval or specific approval for certain operations before conducting such declared operations. For example:
- operations with any defective instrument or piece of equipment or item or function, under a minimum equipment list (MEL) (points ORO.MLR.105 (b), (f), and (j), NCC.IDE.A.105, NCC.IDE.H.105, SPO.IDE.A.105, and SPO.IDE.H.105); or,
- for specialised operations, wet lease-in and dry lease-in of aircraft registered in a third country (point ORO.SPO.100 (c)); or,
- high-risk commercial specialised operations (point ORO.SPO.110); or,
- non-commercial operations with aircraft with a MOPSC of more than 19, which are performed without an operating cabin crew member (point ORO.CC.100 (d)); or,
- use of IFR operating minima that are lower than those published by the State (points NCC.OP.110 and SPO.OP.110); or,
- refueling with engine(s) and/or rotors turning (point NCC.OP.157); or,
- specialised operations (SPO) without oxygen above 10 000 ft (point SPO.OP.195); or,
- Operations in accordance with Annex V (Part-SPA) to Regulation (EU) No 965/2012, including:
  - Subparts B 'Performance based navigation (PBN) operations;
  - $\circ$  Operations with specified minimum navigation performance (MNPS);
  - $\circ$  Operations in airspace with reduced vertical separation minima (RVSM);
  - $\circ$  Low-visibility operations (LVOs) and operations with operational credits;
  - $\circ$  Transport of dangerous goods;
  - $\circ$  Helicopter offshore operations; and,
  - $_{\odot}$  Helicopter point-in-space approaches and departures with reduced VFR minima.
- Note 1: If there is not enough space to list the required information in the declaration, the information shall be listed in a separate annex. The annex shall be dated and signed.
- Note 2: A revised Declaration must be submitted when an aircraft is added or removed from operation or when any of the information in Sections 1 to 7 changes.
  - $\circ\,$  The Declaration Form must include all aircraft types and aircraft registrations operated at the time the Declaration is made.
  - $\circ~$  The fully Completed Declaration Form must be sent by email to  $\underline{ncc-spodeclaration@iaa.ie}$
  - $\circ~$  An automated reply will be issued confirming receipt only of the application.
