Email your completed application form to licensing@iaa.ie, together with:-

- 1) logbook copies clearly identifying at least 6 hours flying as PIC under IFR flown within the validity period of your BIR;
- 2) logbook copies clearly identifying a training flight of at least 1 hour with an appropriately qualified BIR instructor;
- 3) a copy of the instructor's EASA pilot licence clearly identifying the privilege to instruct for the BIR or IR.
